MEMORANDUM

TO: Idaho House and Senate Members

FROM: State Controller's Office Administrator, Division of Human Resources Budget & Policy Analysis Supervisor, Legislative Services Administrator, Division of Financial Management

Each year we receive requests from various legislators to provide certain categorical and statistical information regarding the number of state employees. Each of the four agencies stated above maintain reports containing these numbers. However, since each office has different needs, the reports are not always alike in format and content. Also, categories of employee counts can vary.

The attached report provides a comprehensive list of the number of state employees as of January 9, 2025. Since the state employee work force is highly mobile, a report provided on any other date will naturally vary from the figures in this report. Through the advancement of technology, the financial, personnel, and payroll data warehouse Cognos Enterprise Reporting can provide these same reports on an updated daily basis. Budget analysts from Legislative Services and Division of Financial Management as well as employees in the State Controller's Office and Division of Human Resources have access to these Cognos Enterprise Reports.

For definition purposes of this particular report a State Employee is a person working at an agency of the state of Idaho but does not include patients or inmates. This definition includes part-time employees, however, it specifically excludes: independent contractors and employees of such independent contractors; teachers and other employees of local independent school districts and; individuals who, by law, are not required to be paid through the Office of State Controller.

Active Employee Counts

The four agencies responsible for compiling this information have established the following rules to be used in the calculation of active employee totals:

1. Elected officials are counted once, regardless of any Board, Commission or other memberships.

2. A state employee in multiple positions within ONE state agency will be counted once. Note: If any of the positions are classified, he/she is counted as Classified. Otherwise, he/she is counted as Non-classified.

3. The non-classified temporary/part-time column is the count of employees working less than full-time. It includes Legislative attaches, students, part-time faculty, temporaries, etc.

4. Full-time Board Members such as Tax Commissioners, Industrial Commissioners, and Public Utility Commissioners are counted as regular non-classified employees.

5. Full-time Faculty members are counted as regular non-classified employees.

6. The 'TOTAL – ACTUAL' represents a total of employees per agency. Note: If an employee works at more than one state agency, he/she would be counted in each agency.

7. The State Controller's Office processes payroll for all state of Idaho employees, however, BSU, ISU, and U of I pay their employees separately. Therefore, university employee counts depend upon how an employee is defined by each university.

8. Beginning July 2023, university employee counts include all employees, including student employees, regardless if they are benefitted or not.

9. With the conversion of data from the legacy systems to the new Luma system, there is ongoing data cleanup effort being done to ensure that all employees are being appropriately reported.




