<b>DATE</b>	Enter the current date.
<b>COUNTY NAME</b>	Enter the complete name of county.
<b>AMOUNT</b>	Segregate remittance into various items shown under "Source of Receipt" and enter the amount collected for each item.
<b>TOTAL</b>	Total remittance amount.
